Subject: Creation of the Formulary Executive Council (FEC) for the Philippine National Formulary System (PNFS)

The PNFS shall be composed of the Formulary Executive Council (FEC) that is tasked to review the submissions of manufacturers, doctors, health professional organizations prior to the FEC deliberation, assess these drugs for favorability of their pharmacokinetic and pharmacodynamic properties and evaluate and submit clinical trials/cost effectiveness studies for each drug.

A Chairperson appointed by the Secretary of Health shall serve for a period not exceeding three (3) years with monthly honoraria of **FIFTEEN THOUSAND PESOS (Php 15,000.00)**. Likewise the other members of FEC shall have a term of three (3) years.

The regular members of FEC as well as the non-regular members which will serve as consultants of the DOH, are entitled to collect **TEN THOUSAND PESOS (Php 10, 000.00)** per month as honoraria for actual services rendered as reflected in their output and attendance every meeting. The council shall meet at least once a month, however, government personnel shall not be entitled to honoraria but their participation in the FEC shall be added as intervening points in their Personal Evaluation Scheme (PES).

Under this order all expenses incurred by the FEC and honoraria in the conduct of its function shall be charged against the funds of **National Pharmaceutical Policy Development Including Provisions of Drugs and Medicines, Medical and Dental Supplies to make affordable quality drugs available, A.III.a.5.**
